1.0 INTRODUCTION

The Iwilei Center property is located at latitude 21.3166390 and longitude 157.8665730. The Property consists of three parcels identified by the City and County of Honolulu (“C&C”) as Tax Map Keys (“TMKs”): (1) 1-5-007:009, 029, and 030 (collectively the “Site”). The following addresses are associated with the Site:

- Parcel 009 – 866 Iwilei Road, 414 Kuwili Street,
418 Kuwili Street, and 420 Kuwili Street.
- Parcel 029 – 505 Kaaahi Street.
- Parcel 030 – 850 Iwilei Road and 860 Iwilei Road.

The Property, zoned as IMX-1 Industrial-Commercial Mixed Use, consists of approximately 3.83 acres of land and is owned by Iwilei Center, LLC (“Iwilei Center”). Iwilei Center entered the Voluntary Response Program (“VRP”) administered by the Hawai‘i Department of Health (“DOH”) Hazard Evaluation and Emergency Response (“HEER”) Office to address contaminants associated with various source areas located on the property.

This Public Participation Plan (“PPP”) satisfies the requirements of Section 11-451-15(h) of the Hawai‘i State Contingency Plan for remedial actions and Task 7 of the VRP between DOH and Iwilei Center. The PPP outlines a process and opportunity for the public to be actively involved in the remedy selection for this VRP project.

This PPP was prepared to:

- Raise public awareness of and encourage public participation in the proposed remedial action for the Site.
- Ensure all relevant Site information is available to the public.
- Encourage public comment and input into the planned remedial action.
- Provide opportunities for public participation and comment.

2.0 VOLUNTARY RESPONSE PROGRAM

The VRP was created by DOH to encourage property owners and prospective purchasers to voluntarily investigate and remediate property that may be contaminated. The VRP offers participants technical guidance, expedited oversight and regulatory agency assurance of completed cleanups.

A participant in the VRP completes an application with DOH containing basic information about the proposed project such as a summary of the site history and operations, applicable permits and existing reports, intended scope of work, a statement of financial viability and the consent of the property owner. Upon acceptance of the application, the participant enters into a VRP Agreement with DOH. DOH grants exemption to the VRP participant from future liability related to contamination addressed under the VRP after the participant's satisfactory completion of the voluntary response action and all associated conditions under the VRP Agreement.

The VRP Agreement between Iwilei Center and DOH dated June 14, 2019, as amended on March 18, 2020 (collectively, the “VRP Agreement”) includes a scope of work that is used by the participant to investigate the contaminated property under the Hawai‘i Environmental Response Law. The VRP Agreement for this project requires the following tasks:

- Task 1 – Assess the environmental work completed to date.
- Task 2 – Determine the scope of the remedial investigation and the voluntary response action.
- Task 3 – Prepare a detailed site investigation plan to characterize the environmental condition of the property and provide sufficient data to perform risk assessment.
- Task 4 – Implement the work plans.
- Task 5 – Develop options for alternatives to mitigate and manage risks.
- Task 6 – Perform an Environmental Hazard Evaluation in lieu of a human health and environmental risk assessment, authorized as a suitable alternative per the DOH letter dated September 9, 2019 (DOH, 2019).
- Task 7 – Prepare and implement a public participation plan.
- Task 8 – Select the appropriate voluntary response action.
- Task 9 – Implement the selected voluntary response action.
- Task 10 – Issue the Letter of Completion.

3.0 VOLUNTARY RESPONSE PROJECT OVERVIEW

3.1 Site History

Details concerning the history of the Site have been provided in the VRP Tasks 1, 2, 3, 4 and 5 (ESI, 2019c, 2019d, 2020, 2021a and 2022).

3.2 VRP Contaminants of Concern

The VRP Agreement establishes the site-specific contaminants and contaminated media for the Property. The contaminants of concern for the Site include volatile organic compounds (VOCs); semi-volatile organic compounds (SVOCs); gasoline range organics (TPH-GRO); TPH extractables (TPH-DRO, TPH-RRO); polychlorinated biphenyls (PCBs); organochlorine pesticides (OCP); metals; and dioxins/furans.

The media targeted by this voluntary response action are soil, soil vapor, and groundwater.

3.3 Site Environmental Conditions

Detailed site investigation information is available in the *VRP Task 4 – Site Characterization* (ESI, 2021a). Briefly summarized, Site investigation data indicate the presence of elevated TPH-DRO, TPH-RRO, tetrachloroethylene, benzo[a]pyrene, dibenz[a,h]anthracene, aluminum, arsenic, cadmium, copper, iron, lead, nickel, chlordane, and dieldrin within select areas of the Site. The elevated concentrations detected were likely related to past releases or contaminated fill that was used prior to construction of the building (i.e., pre-1960s).

3.4 Environmental Hazard Evaluation

A detailed evaluation of environmental hazards is included in the *VRP Task 6 – Environmental Hazard Evaluation* (ESI, 2021b). Briefly summarized, gross contamination, direct exposure, vapor intrusion, and leaching for soil were identified as potential hazards for soil. Receptors of concern include residents, future onsite personnel, visitors, construction workers performing work onsite, and nearby aquatic habitats. There were no identified sensitive ecological receptors in the vicinity of the Site. Due to the depth of contamination, concrete and asphalt pavement, and current land use, the contaminants of concern in subsurface soil and groundwater do not pose a hazard to building occupants and the general public under current conditions. However, the contaminants of concern in subsurface soil and groundwater could pose a hazard to human health and the environment if contaminated soil or groundwater is exposed and not managed properly. The data indicates that hazardous substances existing on the Site should be appropriately addressed through implementation of the proposed response action.

3.5 Description of the Planned Remedy

Remedial alternatives were identified and evaluated in the *VRP Task 5 - Remedial Alternatives Analysis Report* (ESI, 2023). Briefly summarized, the Remedial Alternatives Analysis evaluated the following five alternatives: in situ soil and groundwater remediation; ex

situ soil and groundwater remediation; long-term groundwater monitoring and free product recovery; institutional and engineering controls; and no action. For the reasons set forth in the Remedial Alternative Analysis Report, institutional and engineering controls are the selected remedial action for “Continued Present Use” and “Interim Use.” Institutional and engineering controls with limited ex situ remediation, which consists of the proper characterization and disposal of contaminated soil or groundwater displaced during construction activities that cannot be reused on site, is the selected remedial action for the “Possible Redevelopment Scenario”.

The proposed remedies are identified in the *VRP Task 7 – Draft Response Action Memorandum* (in progress). The proposed remedies are also summarized in the attached Fact Sheet (Appendix II).

The institutional and engineering controls includes the preparation and implementation of an Environmental Hazard Management Plan and continued use of concrete and asphalt pavement as a barrier to prevent exposure to subsurface soil and groundwater contamination.

4.0 PUBLIC PARTICIPATION PLAN

This section includes a description of the various elements of the Public Participation Plan for Iwilei Center.

4.1 Public Comment Period

The Draft Response Action Memorandum (“RAM”) for Iwilei Center will be available for public review and comment during the public review comment period. The public comment period will last 30 days following advertisement of the Notice of Availability (see Section 4.4 below).

4.2 Mailing List

The mailing list for the VRP includes tenants, neighboring businesses, individuals, community groups, stakeholders, public agencies, elected officials and other potentially affected and interested parties. A 1,500-foot radius was used to identify recorded owners and lessees near the Site. The mailing list is included in Appendix I.

4.3 Fact Sheet

A Fact Sheet (Appendix II) provides an overview of the VRP process, the Site background and history, the contaminants of concern and the selected remedial actions, or remedies. The Fact Sheet (Appendix II) will be distributed to everyone on the Mailing List (Appendix I) during the public comment period. The Fact Sheet will be part of the information repository (see Section 4.5 below) and will be posted on the DOH website. A copy of the Fact Sheet is included as Appendix II.

4.4 Public Advertisements and Notice of Availability

Following completion of the Draft RAM and approval of this Public Participation Plan by DOH, Iwilei Center will place a Notice of Availability in the Sunday section of the *Honolulu Star Advertiser* newspaper and the State of Hawai‘i’s *The Environmental Notice* announcing the availability of the Iwilei Center VRP documents for public review and comment. Publication of the Notice of Availability will mark the start of the 30-day public comment period. The target date for publication in the *Honolulu Star Advertiser* is Sunday, August 20, 2023. The target date for publication in *The Environmental Notice* is August 23, 2023. If these targeted publication dates are met, the public comment period would commence on August 20, 2023 and conclude on September 19, 2023. If these target dates are not met, Iwilei Center will ensure a minimum thirty-day public comment period commencing on the date of publication in the *Honolulu Star Advertiser*.

The Hazard Evaluation and Emergency Response Office will also publish notice on its website in the form of a news release (Appendix III).

The advertised announcement and the Notice of Availability will be included in the information repository.

FACT SHEET: Draft Response Action Memorandum for the Voluntary Response Program at Iwilei Center in Honolulu, Hawaii

Introduction

The State of Hawaii (State) Department of Health (DOH) is publishing this fact sheet to provide information to those persons interested in the Voluntary Response Program Agreement between Iwilei Center, LLC (Iwilei Center) and DOH at 866 Iwilei Road, 414 Kuwili Street, 418 Kuwili Street, 420 Kuwili Street, 505 Kaaahi Street, 850 Iwilei Road, and 860 Iwilei Road (Property) (Figure 1).

DOH Voluntary Response Program

The Voluntary Response Program (VRP) was promulgated in 1997. The main purpose of the VRP is to facilitate the reuse of contaminated property in a manner that protects human health and the environment. The law provides relief from liability for eligible parties who have not contributed to existing conditions on a specific site, who desire to acquire an interest in that site as owner, lessee or operator, and who participate in a DOH-approved voluntary response program.

Investigations and actions under the VRP include (1) identification of constituents

and media of concern, (2) evaluation of potential risks to human health and the environment, (3) evaluating the applicable remedial alternatives, (4) consulting with the public, and (5) implementing the most appropriate response action for the site.

Iwilei Center became the owner of the Property in 2019 and entered into an agreement with DOH to include the property in the VRP.

Site Description and Previous Uses

The Property is located in the Iwilei District of Honolulu on the island of Oahu. The Property is located in a commercial/ industrial section of the Iwilei District along the north side of Kuwili Street. The TMKs are (1) 1-5-007:009, 029, and 030. The Property is zoned as IMX-1 Industrial-Commercial Mixed Use. The nearest surface water body is Honolulu Harbor, located approximately 200 meters to the south of the Property. Groundwater at the Property is not considered a drinking water source by the DOH.

The Property has had various past uses which included use as an equipment yard, auto and bus repair, machine and welding shop, a jail, the customs bureau and as a gas manufacturing plant.

Characterization of Contamination

There are no ongoing releases or current release sources at the Property. Elevated concentrations of contamination are likely related to past releases or contaminated fill that was used prior to construction of the building in the 1960s.

A site investigation identified contaminants of potential concern (COPCs) above project action levels in subsurface soil and groundwater at the Property. The COPCs relate

to petroleum, metals, and pesticide-related products. A site investigation report is available at the Information Repository for this VRP.

Site Assessment

Hazards from the subsurface COPCs have been evaluated. The Property is entirely paved or covered by the building with the exception of a small grassy area near one corner of the Property. The building and pavement prevent direct exposure to contaminated soil and groundwater. There are no hazards if the subsurface contaminated soil and groundwater is not disturbed.

If subsurface soil and groundwater is exposed, hazards from COPCs need to be managed. These hazards include direct exposure, gross contamination, vapor intrusion, and leaching hazards.

Iwilei Center has analyzed various remedial alternatives for DOH in accordance with the State Contingency Plan which requires evaluation of effectiveness, implementability, and cost. The remedial alternatives were evaluated for both current site conditions and possible future site conditions. This analysis is available in the Information Repository for this VRP.

DOH has selected institutional and engineering controls as the proposed remedy for this Property for continued present use, and a combination of institutional and engineering controls with limited ex situ remedial action if redevelopment occurs. These proposed remedies are set forth in DOH's Draft Response Action Memorandum which is available in the Information Repository for this VRP. The proposed remedy will involve institutional controls and engineering controls. The proposed remedies include preparation and implementation of an Environmental Hazard Management Plan. The Environmental Hazard Management Plan will provide procedures and guidelines for controlling potential hazards posed by capped contaminated media remaining at this site and handling of contaminated materials if the subsurface soil is disturbed.

The Department of Health (DOH) Voluntary Response Program (VRP) was created by DOH to encourage property owners and prospective purchasers to voluntarily investigate and remediate property. The VRP offers participants technical guidance, oversight and regulatory agency assurance of completed cleanups. Pursuant to the VRP, the DOH is proposing a remedial response action for the Iwilei Center site located in Honolulu, Oahu, Hawai‘i. Soil and groundwater at the site contain chemicals as a result of historic industrial operations. The site has been investigated and potential remedies have been evaluated under the VRP, which the current owner voluntarily entered upon acquiring the property. Based on recommendations from the site environmental consultant, as well as a review of the site investigation and remedial alternatives reports, DOH has tentatively selected an environmental remedy that includes preparation and implementation of an Environmental Hazard Management Plan and continued use of concrete and asphalt pavement as a barrier to prevent exposure to subsurface soil and groundwater contamination if the property remains in its current condition. Additional ex situ remedial actions are selected if future redevelopment of the property occurs. The purpose of this notice is to inform the public and obtain public comment about the environmental response action.

Pursuant to Hawai‘i Administrative Rules 11-451-15(i), a Draft Response Action Memorandum detailing this proposed remedy is available for public review and comment. DOH is accepting comments on the Draft Response Action Memorandum for 30 days, after which DOH will evaluate all comments received and make a final remedy selection decision for the site.
